Notes on the declaration regarding the circumstances of an adult child with a disability

People with disabilities are people who have physical, mental, intellectual or sensory impairments which, in interaction with attitudinal and environmental barriers, are likely to prevent them from participating equally in society for more than six months. An impairment according to SGB IX exists if the physical and health condition deviates from the condition typical for the age (Section 2 Paragraph 1 Sentences 1 and 2 SGB IX).

Illnesses whose course is limited to a duration that can be estimated in advance, in particular acute illnesses, do **not** constitute a disability.

When assessing your application, it may be important whether or not your child is in **full-time care**. Your child is in full-time care or in a similar way if he or she does not live with you but is accommodated elsewhere **at the expense of a social security provider** (home/medical/care facility, "assisted living" or own apartment financed by SGB XII benefits; not, for example, if you are cared for in a workshop for disabled people and return to your home every day). If the place in the **facility is available for people with disabilities at all times**, it is irrelevant whether you bring your child home temporarily (e.g. at weekends or during the holidays).

The disability must have existed **before the child turned 25.** For children born up to and including 1981, the disability must have occurred before the child turned 27. For children born after 1981, the disability must have occurred before the child turned 25.

If your child **is unable to support himself or herself** due to his or her disability - i.e. if the type and extent of the disability means that your child cannot engage in gainful employment that enables him or her to cover his or her living expenses - he or she is entitled to child benefit without any age limit if the other requirements are also met.
